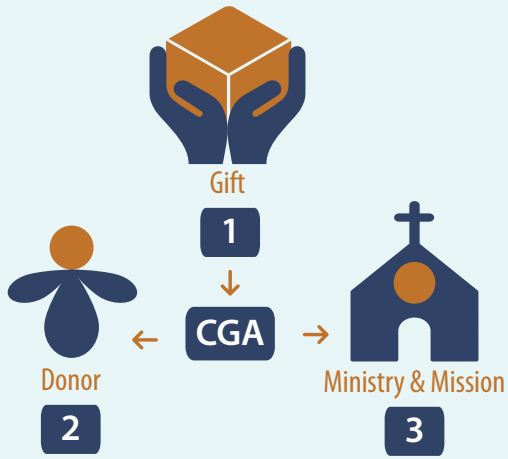

How does a CGA work?



1. You can irrevocably fund a CGA with cash or securities.
2. You will receive generous tax benefits and lifetime income.
3. When the gift annuity matures, the remainder passes to the named charities you recommend.

You can relax knowing...

- You can't outlive the income from an ABF charitable gift annuity.
- The level of lifetime income won't change with the ups and downs in the economy.
- Your gift will help to continue the witness for Christ locally, regionally, and globally.

How to make a gift?

What are my options? Several types of assets may be gifted in reciprocity for a CGA.

■ CASH

A cash gift is an excellent way to fund a gift annuity. A large portion of the annuity income will be tax free.

■ APPRECIATED SECURITIES

Capital gains tax may be bypassed on a gift of appreciated securities to fund a gift annuity. A portion of the income stream will be taxed at the lower capital gains rate and another portion may be tax free.

Flexible payment options:

- You may choose to receive payments quarterly, semi-annually or annually.
- Payments can begin immediately or be deferred (to a later date).
